## Purpose of Role

• Under the general supervision of the animal care technician supervisor, to provide help, assistance and advice to students in learning new skills and other related technical duties.

#### **Principal Accountabilities**

- 1. Help, advise and assist students during their training and whilst carrying out practical activities or assist other lecturers in a classroom as part of a curriculum programme
- 2. Demonstrate the use of equipment or techniques to individual students or groups including all relevant health and safety issues
- 3. Discuss all practical activities with the course teacher
- 4. Observe and maintain all current health and safety regulations as appropriate to the area of work
- 5. Deal with queries when supervising students
- **6.** Establish acceptable standards of tidiness and safety and ensure that students carry out appropriate activities in connection with the above
- 7. Participate in course team meetings, management meetings and staff development activities
- **8.** Maintain personal skills and knowledge relevant to the curriculum and to keep up-to-date in current methods appropriate to the area of work
- **9.** Ensure that practical equipment is available in a serviceable and safe condition for use by the teaching programme
- 10. Prepare materials as required for use by students in practical work and activities
- **11.** Maintain practical equipment necessary for the delivery of the curriculum to a serviceable and safe condition; to refer any equipment requiring repair by manufacturer or contractor to the budget holder
- 12. Be responsible for stock control, storage and maintenance of agreed levels of consumable materials

- 13. Assist in the maintenance of practical areas in a clean and tidy condition
- **14.** Prepare material for course delivery by academic staff, including audio-visual aids and the reproduction of notes
- 15. Maintain, as required, reference material for use by students and staff
- **16.** Supervise students doing project and portfolio work
- 17. Act responsibly in using resources and contribute to, and comply with, efforts and initiatives to reduce carbon emissions
- **18.** Promote and safeguard the welfare of children, young persons and other vulnerable people for whom you are responsible and whom you come into contact with
- 19. Be responsible for own safety and not to endanger that of colleagues/visitors to the workplace.
- 20. Reflect critically on own professional practice used and how your own performance can be improved.
- **21.** Discuss annually at your performance review interview how your performance can be improved and where appropriate agree what actions can be taken for further improvement
- **22.** Undertake such other duties as may reasonably be required of you commensurate with your general level of responsibility at your initial place of work or at another of the College's sites.
- **23.** Monitor the Animal health and wellbeing and take appropriate action should an animal appear distressed or require vetinary care.
- 24. Ensure all animal enclosures are regularly cleaned and optimum living conditions are provided

Learners and Technicians within the Animal Care Department	You will work as part of the delivery team within the animal care Dept. As part of this you will have a critical role in enabling teachers to deliver training and assessments, as well as enabling students to achieve their qualifications in a timely way.
Learners and Parents/Carers	You will be working with the students studying an animal care qualification who range from 16 years and up. This is a support role to enable the learners to achieve their qualifications but you will also form part of the team to ensure students are meeting college expectations and complying with the rules and legislation linked to the animal care centre and the college as a whole.
Lecturers/ Technicians within the area and cross college	This role will involve using good communication skills as well as building relationships with Vetenary Care Practices and Suppliers that will enable the animal welfare to be maintained and supplies to meet the curriculum need. As part of the role you will also need to source and negotiate supplies.
